• **Data subject to processing:**

• **Purpose of processing:**

• **Legal basis of processing**

• **Treatment Modes**

The data is processed by means of computerized and telematic systems by specially appointed internal staff. The data are stored in

electronic archives with full assurance of the security measures provided for by the legislator.

• **Communication and dissemination of data**

The data collected will **not** be disseminated, sold or exchanged with third parties without express consent, except for possible communications to authorized third parties only

where necessary and for the purposes of this information notice. The data may be communicated to the competent authorities, according to the terms of the law.

• **Storage times**

Your data is only stored for as long as it is needed to interact with you and until you decide to unsubscribe from our email list.

• **Rights of the data subject**

Pursuant to articles 13, paragraph 2, letters (b) and (d), 14, 15, 18, 19 and 21 of the Regulation, we inform you that you have the right to ask MIRTA ACCESSORI MODA SRL, as data controller, to process your personal data:

1. **access to your personal data in our possession;**
2. **rectification**
3. **cancellation of the same**
4. **the restriction of processing concerning the same**
5. **to object to their processing, in the cases provided for.**

As a concerned individual, you have the right to lodge a complaint with the Guarantor for the protection of your personal data, following the procedures and instructions published on the official website of the Privacy Guarantor.

Any rectification or cancellation or limitation of processing carried out at your request - unless this proves impossible or involves a disproportionate effort - will be communicated by the Controller without any constraint of form and free of charge.
